

# Privacy Policy

Effective date:

We Agree ("us", "we", or "our") operates the We Agree mobile application (the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

## Information Collection And Use

We collect several different types of information for various purposes to provide and improve our Service to you.

### Types of Data Collected

#### Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personal identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Cookies and Usage Data

#### Usage Data

- You will lose all data, including Profile, Financial, and App data. It is recommended that you use funds or keep track of transaction history before proceeding with a 'Delete Account' Request.
- Your 'Delete Account' Request would be instant in nature. Once your request is processed, you will be unable to log in or use the logged-in feature across DLT Apps ( i.e. DL Wallet & We Agree) linked with your account. DLT Labs will not do any checks over linked apps hence we advise you to utilize funds or take note of transaction history across all apps linked with your account before proceeding for 'Delete Account'. - You will receive an email from DLT Labs informing you about the successful processing of the Delete Account Request
- If you are in contract with another user and the 'Delete Account' request placed by you is successfully processed, then the impact of the contract involving other users shall be handled outside We Agree app as our App is only a facilitator among you and other users. Hence, DLT Labs shall not bear any liability arising out of such transactions
- Your 'Delete Account' request and consent to accept the privacy policy taken during the 'Delete Account' Request shall be stored at our end for audit purposes

Your 'Delete Account' Request would be processed only after successful password validation hence we request you not to share your password with anyone.

We are enabling some permissions to use vibrate, internet and receive boot completed as and when required during the use of mobile application.
